Under promoted Short Code 81121, The cost is £1. Sign-up fee of £1 is applicable. User will receive 4 chargeable messages per week. User will be charged in total £4 per week, until User cancels the Service.

After subscribing to the Services, you will receive a URL which redirects you to the high quality mobile content portal. The content of this portal is constantly updated.

If you cancel the Service, you will automatically stop receiving charges from our Services. Provider will not refund any of your fees paid to date, except as expressly provided in this agreement.
